RE: ESTABLISHMENT OF PREFERENTIAL PARKING DISTRICT NO. 266 AND POSTING OF PARKING RESTRICTIONS

Dear Preferential Parking District Resident:

On July 5, 2018, the Los Angeles City Council adopted Resolution [CF 18-0413-S1](#), which consolidated Temporary Preferential Parking Districts (TPPD) 266 and TPPD 274 in the Westchester area of Council District (CD) 11 and converted them into the newly established Preferential Parking District (PPD) 266. PPD 266 consists of the following blocks:

- Coastal View Drive between the cul de sac west of Shore Cliff Drive and Shore Cliff Drive
- Coastal View Drive between Shore Cliff Drive and Ocean Bluff Drive
- Ocean Bluff Drive between the cul de sac south of Coastal View Drive and Coastal View Drive
- Coastal View Drive between Ocean Bluff Drive and Bluff Trail Road
- Coastal View Drive between Bluff Trail Road and the cul de sac east of Bluff Trail Road
- Shore Cliff Drive between the cul de sac south of Shore Cliff Drive and Bell Crest Drive
- Bell Crest Drive between the cul de sac south of Shore Cliff Drive and Shore Cliff Drive
- Shore Cliff Drive between Bell Crest Drive and Coastal View Drive

You are receiving this notice because your block is located in PPD No. 266. Petitions which meet the Department's requirements were submitted by residents of the blocks below. As a result, signs with the following restriction will be installed on the blocks below.

RESTRICTION: 1 HOUR PARKING, 7 AM TO 7 PM, MONDAY – FRIDAY, VEHICLES WITH DISTRICT NO 266 PERMITS EXEMPT

LOCATIONS TO BE POSTED:

- Coastal View Drive between Bluff Trail Road and the cul de sac east of Bluff Trail Road
- Shore Cliff Drive between the cul de sac south of Shore Cliff Drive and Bell Crest Drive
- Shore Cliff Drive between Bell Crest Drive and Coastal View Drive

You have until **October 12, 2018 to purchase parking permits. Parking enforcement will begin on **October 15, 2018**, after the signs are installed.**

Preferential Parking permit accounts can be opened in person at one of the Customer Service Centers listed below during weekdays (except holidays) from 9:00 a.m. to 5:00 p.m. or you can apply online @ LACity-parking.org--Please have all necessary documents ready to upload in PDF format if you apply online.

To open an account and obtain permits, you will be required to provide a photo ID and **two proofs of residency at the Customer Service Center**. The following may be used for this purpose:

- 1) Driver's License (if it lists your home address in the district)
- 2) Property Tax Bill or Rental/Lease Agreement in your name
- 3) Utility Bill (cable TV, landline telephone bill, internet connection, gas, water or electric)
- 4) Home Renter's Insurance

Cash, credit cards, check or money order are acceptable forms of payment. Permits can be renewed on-line, in-person or by mail.

ANNUAL PERMIT (LIMIT: 3 PER RESIDENCE): Annual permits must be hung from the rearview mirror of the vehicle. They are valid on any block posted with a **PPD No. 266** restriction.

To purchase an annual permit, the vehicle must be registered to an address within the district. You must present the vehicle registration for each vehicle for which you intend to purchase an annual permit at the time of purchase. If the vehicle for which you need a permit is a company vehicle, a letter from your employer confirming the license number of the vehicle and your name must be presented.

The cost for each annual permit is \$34 per year. As PPDs have set expiration dates, purchase costs may be pro-rated if you purchase your permit at a different time. Lost or stolen Annual permits may be replaced upon submission of a written statement of loss and a replacement fee of \$11.50. If you change vehicles, you must also purchase a replacement permit and return the old permit.

VISITOR PERMIT (LIMIT: 2 PER RESIDENCE): Visitor permits cost **\$22.50** each and are valid for 4 months from the date of purchase. This permit can be used on any vehicle but only on the block indicated on the permit. The permit must be hung from the rearview mirror of the vehicle. **Lost or stolen Visitor permits cannot be replaced until they are due for renewal.**

GUEST PERMIT (UNLIMITED ALLOWANCE PER RESIDENCE): Guest permits cost **\$2.50** each, are valid on any vehicle and on any block in your district posted with PPD restrictions. Once an account is open, this type of permit can be purchase by mail (you should allow at least a **3-week** lead time), in-person or on-line. **For technical reasons, only 25 Guest permits can be purchased on-line for a single use date.** Should you require more than 25, you will need to obtain the permits in person or by mail.

Guest permits can be used on any vehicle and on any street that are posted with preferential parking restrictions within your PPD. The guest permits are valid only on the day indicated on the permit.

Visitor and Guest permits are exclusively for the use of the residents and their guests. Penalty for violation of this requirement is loss of parking privileges for a period of one year.

Commercial vehicles are exempt from Preferential Parking restrictions only when performing a service in the District. Vehicles with Disabled Person placards or license plates are exempt from signs which include the phrase: "**District No. 266 Permits Exempt**". No vehicle is exempt from "Street Cleaning" or "No Parking/Stopping" restrictions.
